There is no corporate income tax on retained and reinvested profits. Estonian resident companies and the permanent establishments of foreign entities (including branches) are subject to 20% income tax only in respect to all distributed profits (both actual and deemed).

The fiscal year begins on March 21 and ends on March 20 of the next year according to Iranian calendar.
